

## **Rideshare Parking Policy**

It is with great pleasure that we welcome you to 1201 Wilson Boulevard. We would like to take this opportunity to share with you our Preferred Rideshare Parking Policy.

In order to qualify as a <u>vanpool</u>, all occupants must be registered with a vanpool association such as Van Pool Services, Inc and proof must be presented to JBG SMITH Management. Qualified vanpools will be provided with free parking.

In order to qualify as a <u>carpool</u>, there must be a minimum of 3 or more building tenants riding per vehicle. Qualified carpools will receive a discounted parking rate equal to one half the regular monthly parking rate.

## **Registration Process:**

- 1. Tenant needs to apply for and receive monthly account from Atlantic Parking through their website: <a href="https://www.parkme.com/lot/87252/lot-170-central-place-arlington-va">https://www.parkme.com/lot/87252/lot-170-central-place-arlington-va</a>
  - a. Atlantic will process the application and distribute the AVI sticker.
  - b. To the tenant we recommend not sticking the AVI to one vehicle so that it can be moved to different cars within the carpool.
- 2. Once the monthly account is established the tenant needs to fill out the attached registration form to include the Atlantic account # and return to the JBG SMITH management office.
- 3. Once JBG SMITH's receives the completed form we will send to Atlantic customer care to confirm the acct information and to authorize the that the discount can be applied.
- 4. Atlantic will than apply the discount and notify the tenant when the rate change takes effect

## Additional Notes:

- Reserved carpool spaces will be located on B1 of the N Lynn garage on first come first serve basis. JBG SMITH Management has the sole discretion on location of the spaces but they will be convenient to elevators.
- AVI stickers will be programed to access to both Lynn and Moore garages
